Defendant requests renewal of accreditation from Section 36 to 39 (Primary and Secondary Schools Accreditation) Regulations 2020-21 of the Karnataka Education Act, 1983. Good Rutherford Senior Primary School, Coromandel, KGF, on the recommendation of the Board of Governors, this school will be granted temporary recognition in English medium for a total of 14 sections from 01 to 07th grade from 01st to 07th standard from 2020-21 to 2024-25 as per the following conditions. The renewal of recognition has granted as perment unaided School as per the order.

Conditions:

- 1) Enhancing the strength of the student population in the school.
- 2) The school must provide the entire infrastructure as enumerated under the Education Act 1983.
- 3) Recruiting qualified and trained teachers in the school.
- 4) Security Deposit Fixed Deposit at school.
- 5) Providing compulsory service record of the teachers.
- 6) As per the rule the school has to teach compulsorily in the medium of instruction only permitted by law.
- 7) Follow only the departmental curriculum only
- 8) Fees shall be fixed as stipulated by the Education Act.
- 10) All aspects of the RTE 2009 Act and Rule 2012 must be followed with.
- 11) Being a primary school, the school building should be well equipped and secured. Properly fitting fire Expungers equipment should be used as a precaution.
